6. Bid shall be opened in the presence of Bidders representatives who choose to attend on 21-1-2020 for first tender **13:00 noon** and for second tender on 06-01-2020 **13:00 noon** at the office of Rurukshetra Rural Municipality Baletaksar Gulmi, Nepal.
- Bids must be valid for a period of 90 days for first tender and for second tender 45 days after bid opening and must be accompanied by a bid security amounting to a minimum as mentioned above in table , which shall be valid for 15 days beyond the validity period of the bid . If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[0490010036516] Rurukshetra Ga.Pa. Dharauti Khata at [Mega Bank Ltd. ,Baletaksar , Gulmi ,] and submit the receipt of the deposited amount of cash along with the Bid Document.
7. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
8. The person, firmor company blacklisted as per PublicProcurement Act-2063 with amendment, shall be inelegible to submit the bid and also the proprietor of such firmor company shall be ineligible to submit the bid from another new firmor company.
9. The person, firmor company black listed as per Public Procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firmor company shall be ineligible to submit the bid froman other new firmor company.
10. Matters not covered by this notice shall be in accordance with PublicProcurement Act-2063 with amendment and PublicProcurement Regulation-2064 with amendment and other prevailing regulations.
11. Management costs of 2.5% of the total amount will be deducted.
