5. Bids must be submitted through PPMO's e-GP system <http://www.bolpatra.gov.np/egp> on or before **12:00 hrs of 11-02-2021. Submission of Hard copy will not be entertained**
6. The bids will be opened in the presence of Bidder's representatives who choose to attend at **13:00hrs of 11-02-2021** at the office of Rurukshehra Rural Municipality Baletaksar, Gulmi.
7. Bids must be valid for a period as mentioned in table above after the bid opening and must be accompanied by a **bid security** issued by an **authorized Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law** (Security in the form of cash should be deposited in the Deposit account A/C No.: 0490010036516, Bank name: Mega Bank Nepal limited, Baletaksar, Gulmi), scanned copy of the bid security in pdf format amounting to a minimum as mentioned table above, which shall be valid for 30 days beyond the validity period of the bid).
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

If a bidder submits above several successful (lowest evaluated substantially responsive) bids for the above contracts, the evaluation will also include an assessment of the bidder's capacity to meet the aggregated requirements regarding: Experience, Financial Situations, Cash flow capacity, Equipment to be allocated and Personnel to be fielded.
10. The person, firm or company black listed as per Public procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another new firm or company.
11. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulations-2064 with amendment and other prevailing regulations.
